PLEASE READ BEFORE COMPLETING THE ENTRY FORM.

SANTA CRUZ USBC LOCAL TOURNAMENT RULES AND REGULATIONS

- 1. ELIGIBILITY: Entry will be open to current adult members of the Santa Cruz USBC.
- 2. Any questions affecting eligibility playing rules must be confirmed in writing to the Tournament Director before the tournament prize payments are made. Rule 329 will be upheld regarding Protests and Appeals.
- 3. HANDICAP AND SCORING: The individual method of handicap will be used 90% of 230. Errors in scoring must be reported to the Tournament Director within 24 hours after the score is posted.
- 4. AVERAGE TO BE USED FOR THE TOURNAMENT will be in the following order:
 - he highest book average from the 2021-22 season comprising of at least 21 games.
 - f no average for the 2021-22 season, a current average of 21 games bowled before March 30th
 - ook average for the 2019-20 season comprising of 21 games or more
 - •

f no average in any of the aforementioned categories, bowler will enter scratch (no handicap).

- 4a. Tournament Director has the right to re-rate any bowler that has a higher average of 10 pins of more in another association.
- 5. ENTRY FEES AND SQUAD TIMES: The entry fee will be \$20.00 per person for TEAM EVENT, \$20.00 per person for DOUBLES EVENT and \$20.00 per person for SINGLES EVENT. Entry fee for ALL EVENTS is \$5.00. The prize fund for All Events will be based on total scores from all three events with handicap: Team, Doubles and Singles. If squad time requested is accepted, no entry will be refunded. Entries will be scheduled by request in the order they are received. The schedule will not be changed except in an emergency; only the Tournament Director has the authority to change squad times. Late fees assessed will go in the prize fund for that event. Breakdown of \$20 entry fee: \$6.75 lineage, \$12.75 prize fund, \$0.50 expense fee. Entry Fee for All Events (\$5) goes completely to the prize fund. ENTRY FEES ARE NON-REFUNDABLE.

Women's Division will take the single event scores for this event (if singles event is bowled more than once the first scores shall be used unless the entry fee is paid twice). The \$5.00 entry fee all goes to prize fund.

MULTIPLE ENTRIES:

Singles - Allowed but can only cash once.

Doubles - Multiple entries with a different partner.

<u>Team</u> - Multiple entries with two or more members changing.

All Events - First score in each event will be used towards All Events.

- 6. SUBSTITUTIONS: Substitutions are allowed when a replacement is necessary. The Tournament Director must be advised of substitutes at least an hour before scheduled bowling time, if possible. In case of an emergency after a game has started, a substitute can bowl if one is available. In this case, the combined scores of both bowlers are to count. If no substitute is available, score will be computed on team event only. Rule #212 USBC Local Tournament Rules applies.
 - A substitute will not be required to reimburse the original entrant the entry fees paid nor shall the substitute be expected to give the original entrant any prize money or trophy he/she may win.
- 7. LATE BOWLERS: If a bowler is late, he/she will be allowed to bowl, but is not allowed to make up any frames missed only the frames bowled will count in any event. The Singles Event will be bowled first with the Doubles Event immediately following. If his/her partner hasn't arrived by the time the Singles Event is finished, and a substitute is not available, he/she will be permitted to bowl his/her game in the Doubles Event in order to qualify for All Events.
- 8. FIRST PLACE TIES: First place ties in any event will be rolled off within ten days. Three games will be bowled to decide any ties. The team or individual scoring the most pins will be the winner. The team with the lesser pins will take second place. The Tournament Director will set the roll-off date. The Association will pay the expenses of the roll-off. In the event that the same players are duplicated on both teams, only those not duplicated will bowl. Rule #216 USBC Local Tournament Rules applies.
- 9. PRIZE MONEY AND AWARDS: Prize money paid into each event will be returned to the bowlers in that event only. The prize fund ratio is one in five. When ties occur, other than first place, the places will be combined and equal money will be awarded to each place. Santa Cruz USBC is adding \$500 to the prize fund (Team event \$240; Doubles \$120; Singles \$60; All Events \$45; Women's \$35).
- 10. SANCTION: This tournament is automatically sanctioned by USBC, through the SCUSBC Certificate of Association. Any USBC honor scores that are rolled will be reported to USBC.
- 11. LANE COURTESY: In an effort to keep squads on time, one-lane courtesy is the rule. Anyone observing two lane courtesy will be given a warning and appropriate action taken, including disqualification.
- 12. OTHER RULES: No food or beverages will be allowed in the Pit Area. Participants are required to wear garments in good taste. Bowlers only in the Pit Area; No guests PLEASE.
 - Individual bowlers must not correct automatic scores; only an official can change the score. An official will enter scores on the recap sheet only.
- 13. Rule 319e shall apply to all participants in the tournament.
